This proposal was followed by a long discussion. The rule states that max 4 drivers can be appointed (Chief Driver and 2/3 Drivers), to nominate 5 a rule changes is needed.

After all WWSC members had expressed their opinions, it went to a vote.

The vote did not reach unanimity, therefore the PANAM Confederation was asked to review its position. After a busy email exchange the following drivers were nominated:

The possibility of suggesting to the Chief Judge, based on the results of the surveys, (carried out before the WSC decision on their use), which drivers drive what, was also discussed. The WSC believes that this task should be left to the Chief Judge and the Chief Driver.

Licence for SurePath Data Use.

James Timothy, inventor of SurePath has requested an annual licence fee for the use of the data collected by SurePath.

WSC believes that the collection of this data which, in addition to passing on data to IWWF authorities for the purposes of running and adjudicating sanctioned competitions and retained on a temporary basis for the purposes of record verification, allows:

- drivers to have access to data that pertains directly to them.
- trainers who wish to go through data with their trainees.
- Federation authorities who wish to monitor driver standards and progress in order to make informed decisions on officials' selection for competitions.
- a wider research element which allows data to inform the framing of competition rules in the future. is extremely necessary. CM will speak about it to Jose Antonio.

Fines for late ITE at the IWWF U-21 World Championships.

A few Federations have submitted the ITE for the IWWF U-21 Worlds after the deadline. WSC believe that as this specific request has been reintroduced in the rulebook at the end of March, fines for a late submission of the ITE for this specific event will not apply.

Skiers Representatives elections at Open World. Date and Place

CM has reminded the 3 Skier Representatives that during the next Open Worlds we will hold the Skier Representative elections. It would be nice to set the date and the place in advance and inform all skiers about it.

Tricks Working Group (official appointment of members)

As discussed in the previous meeting a working group to review the rules for Tricks is considered necessary.

Record Certificate

A request regarding the delivery of record certificate to skiers has been received. After a quick investigation, the following was discovered:

Record Certificates had been delivered until 2010. After that date, as the administration of the certificate was complicated with the World President and WSC Chairman having to physically sign the piece of paper, it had been decided to deliver record certificates only on request.

WSC believe that an electronic certificate should be send to all record holders. If they need them they can print them out.
